## JT Legal Group's Accident Guide

**1.** After getting into a car accident, the first thing to do is *take a deep breath*.

While it may be difficult to remain calm, it's important to be careful with what you may say. When insurance companies analyze the details of the accident, any evidence or recordings of apologies or allegations made will be used against them. A mere "sorry" can be used against you, later.

**2.** Closely watch your surroundings. If there are any children or any other injured passengers, tend to them with the best of your capability. If the vehicle is still in working condition, move it safely to the side of the road with the hazard lights on. Blocking traffic or a flowing intersection may cause more severity.

**3.** If the opposing driver is making allegations, be sure to **document** any statements that he, or she, has made. Use a smart phone to record all pictures, videos, voice memos, and other notes to help document the scene of the accident. Be sure to take down the other driver's license number, address, plate number, insurance information, contact information, and as much other information as you can.

**4.** Above all, your health is the most crucial factor in this accident. If you or another passenger is severely injured, seek medical attention *immediately*. Severe impact and whiplash can cause extreme damage to a person's health. If hospitalized, be sure to keep **all** records of the visit.

**5.** Following the event, report the accident with your insurance provider. You'll need to make a claim to receive repairs and settlement for the damages that occurred during the accident.

- Pictures of Any Injuries that Occurred During the Accident
